§ 1

The Library is obliged to make available to the User all services offered, in accordance with the terms and conditions set out in the Regulations of Use of the Public Library in the Ochota District, Warsaw.

§ 2

The legal guardian of the User declares that he has acknowledged and accepts the Terms of Use of the Library in Warsaw's Ochota District, hereinafter referred to as the Regulations and undertakes to:

1. Obey the Regulations
2. Notify the Library about each change of personal data, especially change of address, within 30 days of the date on which]the change was made, under pain of the effects of service of correspondence referred to in Art. 139 § 1 of the Code of Civil Procedure.
3. Take due care of borrowed library materials.

§ 3

The legal guardian of the User declares, after being informed of criminal liability resulting from Art. 233 and 286 of the Criminal Code, that personal data is correct.

§ 4

In the case of Users already registered, the provisions of this Agreement supersede the prior Obligations (record cards) signed by the Users.

§ 5

In cases not covered by this agreement, the provisions of the Civil Code and the Regulations for the Use of the Public Library in the District of Ochota, Warsaw are applicable.

§ 6

Pursuant to Article 6. section 1. lit. a general regulation on the protection of personal data of 27 April 2016, the legal guardian of the User agrees to the processing of:
